APPLICATION OF TARIFF

This tariff sets forth the service offerings, rates, terms and conditions applicable to the furnishing of Intra-Island Long Distance services by AT&T Mobility Puerto Rico Inc. ("AT&T"), to customers within the Commonwealth of Puerto Rico.

1. INTRA-ISLAND LONG DISTANCE SERVICE

1.1 Application of Tariff

This Tariff shall apply to those customers that pre-subscribe to AT&T Mobility Puerto Rico Inc. ("Company") intra-island long distance service. The services will be branded as "AT&T Larga Distancia", hereinafter ALD. The service will allow subscribers to make intra-island long distance calls within the Commonwealth of Puerto Rico.

This Tariff applies to those cases where ALD carries traffic between two subscribers of the Company and any other local exchange carrier.

1.2 Service to be Provided

ALD shall provide the services included in this tariff as long as the conditions (technical and natural) are present for the provision of service. ALD reserves the right to, pursuant to applicable statutes and regulations, disconnect and/or terminate service to a subscriber who does not comply with the terms and conditions for the services listed in this tariff.

1.3 Billing and Payment

ALD shall bill for the services received by the client. The invoice will include any regulatory, legal charges and any taxes required by law. The client shall then have a period of thirty (30) days to pay the invoice.

2. OFF-NET INTRA-ISLAND LONG DISTANCE

2.1 Off-Net Long Distance Plan

This plan applies to customers who use ALD as their pre-subscribed long distance company for their intra-island calling.

A) Residential Customers

Charges are based on a flat rate of \$0.09 per minute, 24 hours a day, 7 days a week. Billing is done in full minute increments.

B) Business Customers

Charges are based on a flat rate of \$0.08 per minute, 24 hours a day, 7 days a week. Billing increments are based on the original thirty (30) seconds of the call and then each additional 6 seconds.

3. POST-PAID LONG DISTANCE

3.1 Post-Paid long Distance Cards

Company offers post-paid long distance services for intra-island calls. Intra-island long distance calls will be charged at \$0.10 per minute. Billing will be done in full minute increments. There is a one-dollar (\$1.00) connection fee per call.
